Issues Making a Splash This Week

- **All's Fair in Love and War:** President Trump is heightening scrutiny of defense contractors and has called for a \$1.5 trillion defense budget in FY27, though Democrats' increasing leverage due to their expected win of the House majority in the midterm elections makes a big boost in Pentagon spending more challenging. DEFENSE DISRUPTION UNDER TRUMP: President Trump issued an [executive order](#) (EO) on Tuesday seeking to address perceived underperformance by defense contractors by targeting stock buybacks, dividends, and executive compensation. **The EO does not directly prohibit stock buybacks and dividends but rather gives Secretary of Defense Pete Hegseth a cudgel to pressure contractors to meet the Pentagon’s expectations regarding contract performance.** The EO directs Hegseth to conduct a review of defense contractors that are not adequately performing, failing to invest in production capacity or prioritize federal contracts, or producing too slowly. The Department of Defense (DOD), also known as the Department of War, will ask those that don’t meet the grade and who have engaged in stock buybacks or made distributions to shareholders to submit a “remediation plan.” If that plan is not accepted, Hegseth can take enforcement steps, including

using the Defense Production Act (which allows the White House to control industries on an emergency basis) and federal acquisition authorities. The EO also directs future defense contracts to condition stock buybacks, corporate distributions, and executive compensation on contract performance. In a Truth Social post, Trump specifically [criticized](#) **RTX (RTX)** as “the slowest in increasing their volume, and the most aggressive spending on their Shareholders.”

The executive order underlines the Trump Pentagon’s priority of reshaping procurement, the subject of a wide-ranging memo issued in November. Added pressure on legacy primes could create a wider path for Little Tech to win defense contracts. **Trump’s latest defense EO presents headline risk but should be seen as a bid to exert maximum leverage over the defense sector to realize the DOD’s new vision for acquisition.**

While Trump’s EO, signed on Tuesday, heightens scrutiny of defense contractors, he posted on Truth Social on Wednesday, [calling](#) for a \$1.5 trillion defense budget in FY27. This spending target is a reversal from the president’s first proposed defense budget for his second term. Trump’s FY26 budget request to Congress kept discretionary defense spending flat relative to FY25, which would amount to a cut in real terms. This fiscally austere approach likely reflects the influence of noted fiscal hawk Office of Management and Budget Director Russ Vought. Republicans gave the Pentagon a \$150 billion boost in the One Big Beautiful Bill Act, but this was a one-time infusion of cash.

Trump’s defense spending aspirations for FY27 notwithstanding, Congress still has to finish FY26 appropriations. It’s not yet clear whether the Pentagon will end up with another year-long continuing resolution (CR) or whether Congress will pass a new FY26 defense spending bill. House Appropriations Committee Chair Tom Cole (R-OK) told Politico this week that a bipartisan defense spending bill would track with the National Defense Authorization Act (which was \$8 billion above Trump’s topline) or go higher than that. While Democratic defense hawks may support a boost to defense spending, the party is unlikely to allow a defense spending bill to pass without using their leverage for nondefense spending as well. “Defense and Labor-H will have to be paired together,” Senate Majority Leader John Thune (R-SD) told Politico, referring to the bill that funds the Departments of Labor, Health and Human Services, and Education. “The Dems are not going to let Defense move without having Labor-H go with it.”

Congress technically faces a September 30th deadline to pass FY27 appropriations, but lawmakers are likely to punt it until after the midterm elections, given the political realities of campaign season. Historical trends and current polling favor Democrats to win a majority in the House. The small number of competitive districts makes a wave unlikely, but House Speaker Mike Johnson’s (R-LA) razor-thin majority is likely to flip. If House Democrats win a majority as expected, they would have no incentive to cut a deal on FY27 spending in the lame duck session and would have even more leverage under divided

government. In that scenario, **Democrats would be likely to seek a return to parity in defense and nondefense spending increases. This would make a big boost for the Pentagon more challenging in FY27.** The DOD is unlikely to receive a large windfall beyond the \$150 billion from Republicans' reconciliation legislation, which is spread over multiple years.

AI AND AFFORDABILITY FIGHT OVER THE GRID: The Trump administration has incompatible priorities when it comes to energy. On the one hand, the White House is all-in when it comes to AI. It proudly touts data center investments at press conferences. One executive order states that "Continued American leadership in AI is of paramount importance to maintaining the economic and national security of the United States." Energy Secretary Chris Wright is comparing the AI race to the Manhattan Project. On the other hand, the White House is "obsessed" with combating rising energy prices. President Trump held a high-priority briefing last month, with the chief of staff and two Cabinet secretaries present, to discuss the administration's actions to reduce power costs, signaling that it had become "a top priority" for the president to politically combat affordability critiques.

AI is threatening to break the grid. ERCOT, Texas's power grid, ended 2025 with 233 gigawatts (GWs) of power demand in the queue from large loads seeking grid connection, a 269 percent increase from the year before. Data centers alone represent 77 percent of this queue. For reference, **this is more than twice Texas's total installed generation capacity and almost three times its record demand.** Across the country, utilities are overwhelmed by interconnection requests. ERCOT's rules were written with the expectation that 40 or 50 large loads would be seeking entry at any one time, per a body executive, but the utility had received 225 new requests through November of last year. The long-term forecast of the country's largest regional grid, PJM, found that more than 90 percent of the new generation required through 2030 is due to data centers. **Nationwide, more than half of all demand growth in utility load forecasts is just data centers.**

This unanticipated demand is already affecting markets and driving up electricity prices for everyone. Residential utility rates have risen by more than a third nationally on average since 2020, and electricity has broadly outpaced inflation since 2022. More than 24 percent of households were unable to pay their energy bills in full in 2024, and 36 percent of adults reported that the bills were a "major" source of stress in a poll last month. Data center forecasted load specifically accounted for \$21.3 billion in costs for PJM's last three capacity auctions, or almost half the total. **This price surge is manifesting in politics. Democrats utilized spiking utility costs in Virginia, New Jersey, and Georgia last year as part of an affordability message to great effect.** In the first, the Democratic gubernatorial candidate insisted that centers "pay their own way and their fair share," while in New Jersey, both candidates dedicated between 25 and 30 percent of all ad spending on energy and climate issues. Garden State Democratic

Governor-elect Mikie Sherrill ran on declaring a state of emergency on [Day One](#) and freezing utility rates. **Electricity became a “kitchen table issue” comparable to recent persuasive messaging on the price of eggs or gasoline.** The Trump administration’s focus on countering with its own energy affordability message is an implicit acknowledgment of the strategy’s success. Pushback to data centers at the state and local level is ramping up: from March through June of this year, an estimated [\\$98 billion](#) in projects were blocked or delayed. **The anti-AI push** (or at least, data center power concerns) is bipartisan. Senator Bernie Sanders (I-VT) in recent days proposed a national moratorium on data center construction, but other critiques have also been raised by state and federal Republicans, including a state law in Texas last year imposing greater restrictions and requirements on large load customers.

Both state and federal regulators are trying to balance these competing interests. Around the country, there are at least 65 large-load tariffs, either pending or in place, in 34 states to resolve these issues, of which 46 were newly enacted in [2025](#). Common contract elements include obtaining commitments from data centers, which frequently submit multiple connection requests to different grids simultaneously to keep their options open. Politico reports that PJM intends to release a new forecast this month that will include “appreciably lower” projects, on the back of a more skeptical accounting of the demand for data centers. **The highest-profile deliberations have been taking place at the Federal Energy Regulatory Commission (FERC), where newly installed leadership reflects both the administration’s desire to build alongside price and reliability concerns.** The body ruled last month that PJM’s rules regarding co-location — when tech companies build private generation alongside their on-site data centers — were unjust and unreasonable. FERC directed the regional grid to revise its rules to accommodate co-location arrangements. PJM is required to submit tariff revisions to the different requested modifications by January 19th and February 16th.

Separately, FERC has also been requested to assert new power over the interconnection process by the Department of Energy (DOE) in a rare procedural move that requires the body to consider and vote on the administration’s proposal on an expedited timeline: April 30th. While FERC is not obligated to approve DOE’s proposed rule either in full or in part, it is largely sympathetic to its objectives and empowers it with legal justification to act quickly. **If the commission acts expeditiously to create a national framework permitting colocation, tech companies would have the greenlight to pursue their preferred solution for supplying their data centers, while the administration could say it protected households from being swept up in the AI electricity frenzy.**

VENEZUELA PUTS RUBIO IN THE SPOTLIGHT: From the outside, Rubio’s ascension within the Trump administration is both surprising and meteoric,

particularly given its beginnings. The secretary of State, who's long been known for his hawkish views on foreign policy, was almost immediately stuck with an acting undersecretary of state who had previously [derided](#) him as "low IQ," thrust into a [battle](#) with Elon Musk over how to run his agency, and mocked for his body language during a now infamous Oval Office meeting between President Trump and Ukrainian President Volodymyr Zelenskyy. But only a matter of months later, it was Rubio who was serving not only as secretary of State but also as acting chief archivist, acting administrator of USAID, national security adviser, and, now, as a leader on the team overseeing Venezuela's leadership transition.

While Rubio's ever-expanding portfolio has become something of a running joke he himself [plays up](#) in Washington, it's also a symbol of the increasing amount of trust President Trump places in him. In May, Axios [reported](#) that, like Vice President Vance, Rubio had rapidly grown in Trump's favor, in part because of his ability to forge relationships beyond politics and in part because of his frequent defense of the administration on prominent Sunday talk shows. Behind the scenes, Politico [reported](#) that Rubio's willingness to jettison old positions in favor of some of the president's foreign policy stances also helped improve his standing in Trump's eyes.

All told, Rubio's been loyal to Trump, and that loyalty has paid off, making him a powerful secretary of State.

But when it comes to the latest US operations in Venezuela, the secretary of State is out on his front foot. Unlike some of the president's other major foreign policy initiatives, this one is Rubio's brainchild. According to [reporting](#) from CNN, "Rubio spent the months leading up to Saturday's operation huddled at the White House with Trump's deputy chief of staff Stephen Miller to craft the strategy." Both Rubio and Miller have held longtime hardline stances on Maduro and Venezuela, making them an unlikely duo, but one that ultimately helped tip Trump toward a military intervention.

Now, the Washington Post [reports](#) that "Rubio will play an outsize role in guiding U.S. policy as the Trump administration attempts to stabilize Venezuela." The secretary of State featured prominently on Sunday shows in the wake of the operation while also serving as the administration's [point of contact](#) with GOP lawmakers. In classified briefings to Congress, Rubio has laid out a three-part [plan](#) for governing Venezuela moving forward.

For Rubio, the new role offers plenty of upside. While the secretary of State has so far ruled out a presidential run, preferring instead to throw his support behind Vance, there's plenty of time between now and 2028. **A high-profile turnaround in Venezuela, paired with his proximity to Trump, would create a strong launching pad from which to campaign should he change his mind on his presidential ambitions.**

On the other hand, the operation includes several potential pitfalls for Rubio, beginning with the risk of failing to meaningfully stabilize the country without further military intervention. **Closer to home, overshadowing Trump's role could similarly risk Rubio's positioning within the administration, although the secretary of State has demonstrated his ability to navigate similar pressures so far.**

Unrelated to Rubio's presidential ambitions (or lack thereof), it's also worth noting that if it's believed to be too much on his plate, Rubio's stewardship of Venezuela's transition could be partially ceded to Miller. The Washington Post [reports](#) that "the White House is weighing giving Stephen Miller, Trump's deputy White House chief of staff and homeland security adviser, a more elevated role in overseeing post-Maduro operations in Venezuela." While Miller previously viewed Venezuela as a key component of his domestic deportation strategy, CNN reports that he came around to the view that military intervention was more important than strong relations for the sake of immigration policy. Even so, it remains an open question whether a Miller-led rebuild of Venezuela would lead to a return of Venezuela as a home for deportations.

A Quick Look Back

House

On Monday, the House was not in session.

On Tuesday, the House held a recorded vote on the quorum call to begin the second session of the 119th Congress.

On Wednesday, the House adopted a rule to allow floor debate on a three-bill minibus package covering FY26 appropriations for Commerce-Justice-Science, Energy-Water, and Interior-Environment, and a bill that would extend expired Affordable Care Act premium subsidies for three years. The chamber also advanced a resolution providing for consideration of a bill that would extend the enhanced tax credits to purchase health insurance under the Affordable Care Act markets. The House also began consideration of a bill that would define a showerhead such that each head of a multi-head showerhead fixture is to be considered a showerhead that is allowed to spray up to 2.5 gallons per minute.

On Thursday, the House passed a minibus that would provide FY26 appropriations for Commerce-Justice-Science, Energy and Water Development, and Interior and Environment, and a bill that would extend recently expired Affordable Care Act premium tax credits for three years. The House also failed to override the veto messages to accompany the Finish the Arkansas Valley Conduit Act and the Miccosukee Reserved Area Amendments Act.

Today, the House will reconvene at 9:00 a.m. and is expected to consider a bill that would repeal energy efficiency requirements for manufactured housing, effectively returning manufactured housing energy efficiency to standards set in 1994.

Senate

Putting the Rib Back in the McRib: McDonald's is [facing](#) a class-action lawsuit over allegations that its McRib sandwich contains no real pork, a claim the case argues reasonable customers would not believe given the name and presentation of the menu item. The plaintiffs argue the sandwich instead has lower cuts of pork, including pork shoulder, heart, tripe, and scalded stomach. McDonald's has disputed the allegations, stating that the "sandwich is made with 100 percent pork sourced from farmers and suppliers across the US." It also said it does not use pork hearts, tripe, or scalded stomach, as they are not allowed in McDonald's pork products.
